### **EU Sanctions on Steel**

Former U.S. Deputy Treasury Secretary Stuart E. Eizenstat and John M. Weekes, former Canadian ambassador to the World Trade Organization, talked about EU-U.S. trade relations 17 May at a National Press Club Morning Newsmaker Program in Washington. They predicted that a real chance exists for EU trade sanctions on U.S. goods as a result of the steel dispute between the United States and the European Union. However, they say retaliation over the FSC Repeal and Extraterritorial Income Exclusion Act is far less likely.

JØRGEN PETERSEN 1940 - 2002

It is with great sadness that we inform you of the untimely death of Jørgen Petersen. Jørgen was only 62 years old. Jørgen's death is a heartbreaking loss to his family, his friends and business associates. He was a very valued member of the Danish community in the greater New York area. He was a board member of The Danish American Society, where his advice and dedicated contribution to the Society will be sorely missed. Jørgen was also a great supporter of The Rebild Society and Gunnar Nu Fonden in Denmark.

Jørgen would always describe himself as "Københavner med stort K". He was born on Vesterbro in Copenhagen, and as he said, "I was pretty good at playing soccer." Typical modest Jørgen, in 1960 became a very successful professional soccer player in Italy together with his life-long friend, Harald Nielsen. After finishing his glorious soccer career in The North American Tournament, he became part owner of a Canadian Distribution company - where Jørgen, as president, built-up the company to 4.000 employees with sales around 1 billion dollars. Jørgen's next business success was in Puerto Rico, where he developed a large factory for leather goods - supplying companies like Pierre Balmain, Nina Ricci, Versace, etc. Jørgen Petersen believed very much in charity. Large donations were quietly made to many charitable organizations. After September 11, Jørgen donated a large amount to the N.Y. Firemen's Fund and when "Guld Harald" Nielsen turned 60 not long ago, they donated a brand new fire truck to New York City. Jørgen lived in New York City and New Jersey. He was proud to be an American resident, but his heart and his whole wonderful demeanor was still very Danish.

We will all miss Jørgen - probably much more than this generous and modest man would ever have dreamt of.

E and L Spousal Employment Authorization and Six Month Intracompany Transfers Now Law In January 2002 President Bush signed into law two bills that authorize employment of spouses of L and E visa holders. In addition, the L-1 provisions reduce from one-year to six months the pre-employment requirement for U.S. employers transferring workers from foreign subsidiaries and branches, provided the employer has an approval Blanket L petition. With the passage of these bills, the U.S. joins the growing number of countries, such as Argentina, Australia, Canada Hong Kong, Italy, Netherlands, Sweden, and the United Kingdom.

The Ellis Island Medal of Honor was created in 1986 to honor the many ancestral groups who through struggle, sacrifice, and success helped build America. Four Presidents, several build America. Four Presidents, several senators, Congressmen and Nobel Prize Senators, Congressmen and Nobel Prize Winners are among the impressive group of individuals who previously have received the Ellis Island Medals of Honor for their outstanding contributions to America. Sanctioned by the United States Congress, medal recipients are listed in the Congressional Records in Washington.

Flemming Heilmann has been an active member of the Danish community in the United States. serving on the boards of both the Danish American Chamber of Commerce and the Danish American Society in New York. He was the Danish Olympic Committee's US representative from 1994-1996 in preparation for the Atlanta Olympics, and served as an attaché for the Danish Paralympic Team. He is a New York representative of Danes Worldwide, and was in 1998 appointed Knight of the Order of the Dannebrog by the Danish Queen. Heilmann is a Trustee of the American Scandinavian Foundation, New York, Vice President of the Board of the Jacob A. Riis Neighborhood Settlement in Queens, New York, and a Trustee of Paul Smith's College of the Adirondacks. He served as a Director of the American Friends of Cambridge University and was elected a Wilkins Fellow of Downing College, Cambridge University, in 1999. Heilmann was a member of

Comell University Council 1996-2000, and he and his wife, Judy Heilmann, have endowed an annual graduate scholarship for outstanding economists from Copenhagen University to study at Comell University.

Maersk Air suspends domestic flights to Bomholm and Billund Maersk Air has suspended the domestic flights between Copenhagen - Rønne and Copenhagen - Billund as of Sunday May 12, 2002. International routes as well as routes to the Faeroe Islands and Aalborg are not affected. "The decision has been hard, and today is a sad day in Maersk Air's history, but the size of the loss determined this phase out" says Flemming lpsen, President of Maersk Air. "In recent years we have experienced strong competition from the bridge across Storebælt, the bridge across Øresund, trains and fast ferries and these two scheduled routes have failed to provide a satisfactory result. This competition along with additional charges imposed on Danish domestic flights has made the decision inevitable". The decision has an immediate impact on employees at the Maersk Air Station Office in Rønne. Employees at Maersk Air Station Offices in Billund and Copenhagen are not affected. For travellers on these two routes, who have already booked and received tickets, alternative transportation will be offered. # First Danish President & CEO of the SAS Group visits New York.

In his new capacity as President & CEO of the SAS Group, Jørgen Lindegaard, visited New York on April 4th. At a reception for members of the Danish American Chamber of Commerce held at the Royal Danish Consulate General Jørgen Lindegaard held an inspiring presentation of the present state of affairs concerning Scandinavian Airlines.

The keen attention of the audience was held throughout the review of immediate and projected developments flowing from the projection of the European economies and the Euro's physical introduction as the everyday currency of all but three member countries of the Union. It was predicted that it would be six to ten Union the "out countries" would effectively have changed their physical currency to the Euro. Later Niels Thygesen stimulated his isteners with comments on how some Europeans felt that Allan Greenspan might have done a few things differently in executing his strategy to protect the USA from damaging inflationary trends. It was also suggested that American productivity was not really so far ahead of Europe's, when expressed in hourly terms; but Europeans did not work as many hours as Americans do: "the Europeans are just lazier!"

American Scandinavian Foundation's President. Ed Gallagher, welcomed the visitors to Scandinavia House and Consul General of Denmark, Ambassador Michael Metz Morch. extended a welcome on behalf of the Consulate and the Danish and Norwegian Chambers of Commerce which had collaborated in sponsoring the event. Morch pointed to the critical importance of strong economic and trade ties between the USA and Europe. The Consul General then asked Flemming Heilmann to introduce the speaker, saying that Heilmann had taken the initiative in making the event happen as one of his many efforts to foster the 'umbilical" ties between the USA and Denmark. Fl. Heilmann, who is a Trustee of ASF and a Board member of DACC, described Niels Thygesen as "a renaissance man among leading academics and economists," drawing attention to Thygesen's five Danish national golf championships, his years as Chairman of the Danish Olympic Committee, and his role as

economic development advisor to the Malaysian Government after that country gained its independence. Peter Hessellund-Jensen, President of DACC, thanked Niels Thygesen for his illuminating talk, and presented him with a big (crystal) apple as a memento of his New York visit before opening the meeting for a lively Q & A session.

Those attending the event had an opportunity to mingle and to meet Niels Thygesen and his wife, Irene, during the reception at the end of a stimulating evening in a lovely setting.


